In accordance with the provisions of the Administrative Procedure Act, R.S. 49:950 et seq, specifically R.S. 49:968(D), the Board of Drug and Device Distributors is submitting this report concerning any comments received regarding proposed rule amendments to the above regulations and/or adoption of regulations with regards to recent amendments to the Board's statutes passed by Act 443 of the 2015 regular session of the Louisiana legislature; particularly, the transition to licensure for distribution of legend drugs and device from licensure for wholesale distribution, the addition of license sub-types to the drug and device distributor license, and restructure of fees to correspond with licensure sub-type.
